Call for Applications

The World Trade Institute of the University of Bern, Switzerland and the Centre for WTO Studies, Indian Institute of Foreign Trade, India are pleased to announce the launch of the **2024 WTI – CWS Joint Academy on International Trade Law and Economic Policy ("Joint Academy")**, which will take place through a **physical mode** from **03 June to 14 June, 2024**. Since its inception in 2014, the Joint Academy has provided law students and legal professionals in India a rare opportunity to deepen their knowledge on aspects of International Trade Law and Policy. It brings us great pleasure to announce that this **10th edition** of the Joint Academy will extend this exceptional opportunity to economics students and professionals. The **Joint Academy (Economics)** is designed to span a duration of 2 weeks, while the **Joint Academy (Legal)** will span a 4 weeks duration. Taught by distinguished academics and practitioners from India and abroad, the Joint Academy will equip participants with theoretical and practical insights into various issues relating to international trade law and policy.

ABOUT THE JOINT ACADEMY (ECONOMICS)

Dates: 03 June to 14 June 2024

Mode: Physical at the Centre for WTO Studies, NAFED House, New Delhi

Modules: *Week 1* – Essentials of WTO Law; Introduction to Economics of Trade

Week 2 – Economics and Practice of Global Services Trade; Preferential Trade Agreements; Trade and Environment

WHO CAN APPLY

- All students enrolled in any economics course in India, either at the undergraduate or postgraduate level. Preference will be given to students who have prior exposure to issues relating to International Trade Economics.
- The Joint Academy is also open to Indian economics professionals who can attend specific modules in a flexible, “à la carte” manner. Unfortunately, this option is not available for students.

- The maximum number of participants that will be selected for the Joint Academy is **30 (thirty)**.
- Selection of candidates is at the final discretion of the Centre.

HOW TO APPLY

- Interested candidates are required to complete the Application Form for the Joint Academy and send the same, along with their updated CV, to jointacademy@iift.edu

FEES STRUCTURE

For Economics Students: **INR 6,000/-** (For the whole duration of the Joint Academy)

For Economics Professionals: **INR 12,000/-** (For the whole duration of the Joint Academy)

INR 8,000/- per weekly module (For applicants applying for specific modules)

FINANCIAL SCHOLARSHIP

With the objective of attracting the best participation, CWS provides a refund of course fees for students who meet the minimum attendance criteria of 80% per week **and** attain the minimum pass percentage of 70% in each module in the Final Evaluation.

CANCELLATION POLICY

A candidate who has been accepted for the Joint Academy and has made payment in furtherance thereof may withdraw subsequently. However, such withdrawals can be made no later than May 10, 2024 and are subject to a deduction of 50% of the fees paid. No cancellations and refunds will be entertained after May 10, 2024.

ATTENDANCE AND FINAL EVALUATION

Classes are held typically 5 days a week, from 9:30 a.m. to 4:30 p.m. (Timings may differ for some modules). Participants are required to attend **all classes**. The minimum attendance requirement is 80% per week.

For evaluation, an examination will be conducted. Details about the mode of examination shall be communicated to selected participants.
