IIFT is a premier institution of education, training and research in the area of International Business set up by Department of Commerce, Government of India. The Centre for Research on International Trade (CRIT) which is a part of IIFT has three Centres under it with the Centre for WTO Studies being one of them.

The Centre for WTO Studies was established at the Indian Institute of Foreign Trade in November, 2002. Centre is a professional body which conducts independent research and training programmes on the WTO and related matters.

For its research work on **WTO and services trade**, the Centre intends to engage Researchers either at the level of Research Associate (Economics/Legal) or Research Fellow (Economics/Legal). The engagement shall be purely on contractual basis for a period of one year. The candidate should possess the following qualification:

MA(Eco)/MA(International trade)/M.Phil (Economics)/LLB with sound knowledge of computer application and packages [M.S. Word, M.S. Access, M.S. Outlook, Excel, Power Point]. The candidate should have good command over English (spoken as well as written) and should have interest in research activities.

Experience: The candidates having experience in research on WTO issues **particularly on services trade** in any reputed organization shall be preferred.

Tenure: The appointment will be purely on contractual basis for a period of one year with a possibility of further extension based on the performance.

Emoluments: The Researchers shall be paid fixed monthly emoluments depending upon their qualification and experience as under:

Research Associate (Eco): Rs.30, 000/- per month

Research Fellow(Eco): Rs.36, 000/- per month

In addition, a candidate engaged as a Research Fellow shall be entitled to medical facilities, Earned Leave and LTC whereas a candidate engaged as a Research Associate shall be entitled to medical facilities and Earned Leave only.

The selected candidate will need to join immediately.

Candidates who have been awarded Post Graduate Degree in Economics/Degree in Law and who are in possession of their Degree/Provisional Degree **should only** apply. The candidates should also enclose a scanned copy of their degree/provisional degree along with the application failing which the application will be rejected.

Indian nationals having the above qualifications and experience should only apply and send their c.v. by email to Shri A.K. Lahiri, Administrative Officer, Centre for WTO Studies, IIFT, New Delhi (**email id: aklahiri@iift.edu**) latest **by 30th July, 2018**. The shortlisted candidates shall be called for written test, computer skill test and interview before the Selection Committee at the Centre for W.T.O. Studies (8th Floor), NAFED House, Sidhartha Enclave, Ashram Chowk, Ring Road, New Delhi - 110014. The date and time of the test and interview shall be intimated to the shortlisted candidates only in due course. It is also brought to the notice of all concerned that no TA/DA shall be payable to the candidates appearing for written test and interview and that the candidates coming from outside Delhi shall have to make their own arrangements for stay in Delhi and the Centre shall neither pay nor arrange for their accommodation.
