IIFT is a premier institution of education, training and research in the area of International Business set up by Department of Commerce, Government of India. The Centre for Research in International Trade (CRIT) has been established by the Ministry of Commerce and Industry (Department of Commerce) as a part of IIFT. It is proposed to recruit a Chairperson who shall be the Chief Executive Officer of CRIT.

### **Purpose and Objective of CRIT**

The CRIT is envisaged to function as a think tank on global trade and investment issues and a focal point for research on these areas. In pursuit of this primary objective, the CRIT shall act as an apex body and will be responsible for engaging, overseeing and coordinating the research and capacity-building activities of the three Centres created under it, which include: Centre for World Trade Organisation Studies (CWTOS), Centre for Regional Trade (CRT), and Centre for Trade and Investment Law (CTIL).

### **Educational and other qualifications required:**

(1) Application from reputed professionals with a deep understanding of international trading and investment system and having a distinguished record in at least one of the following are required:

- (i) direct participation in international trade/investment policy formulation and trade/investment negotiations; or
- (ii) international trade (economics, law, investment policy, or economic diplomacy) with extensive experience of having served in academia with demonstrated track record of publications in reputed international journals and relevant administrative experience; or

(iii) corporate sector with demonstrated track record of direct involvement in international trade/investment promotion.

(2) A minimum of 20 years of experience in academia or government or senior management positions in industry or corporate sector with at least 5 years of core experience in the field of international trade/investment.
