Objective and Scope of the Study

- Estimate the size of Government Procurement markets in US and EU
- Estimate category-wise procurements
- Estimate the import content of procurement
- Estimate India's likely share



- Service procurement had been much larger than goods procurement in all markets
- Procurement by USA from non-US sources:
 - -6.27 % of the total procurement in 2008 amounting to USD 29568.75 million
 - -7.09 % in 2009 amounting to USD 29787.65 million



- European Union Market: Procurement from non-EU sources
 - Abysmally low
 - UK
 - -0.12 % in 2008
 - -0.003 % in 2009

• Germany

-0.02 % of its total procurement in 2008, which amounted to 34.02 million Euro

- No non-EU source was contracted in the year 2009



- Sector specific observations
 - pharmaceuticals: the largest non-US source in procurement by the US government
 - IT & ITeS: larger share in the total procurement by the US government, but smaller share for the non-US sources
 - Total procurement of IT and ITES in 2009: 10805.69 million USD
 - 1.01 % (109.13 million USD) from non-US sources
 - Total procurement of pharmaceuticals: 360.64 million USD
 - 14.55% (52.47 million USD) from non-US sources



- UK: total procurement of IT & ITeS in 2008 worth 600 million Euro
 - -only 0.02 % percent procured from the non-EU sources
- Germany: total procurement of IT & ITeS worth 573.8 million Euro in 2008
 – only 0.01 % procured from Australia



- USA: By the most optimistic approximation, USD 49.83 million worth of Goods and USD 382.77 million worth of Services could have been procured from India
- EU: USD 10-12 million worth of Goods & Services could have been procured from India
- These amounts are only indicative of actual gains that could have been realized




Nature, Size and Trends in Government Procurement by USA

- The total number of procurement transactions during 2008-2009 that were analyzed has been around 8 million
- The data is collected from the Federal Procurement Data System - Next Generation (FPDS) site (URL: https://www.fpds.gov/fpdsng_cms/index.php)
- three broad categories of tendering procedures:
 - Full and open competition
 - Not available for competition
 - Not competed
- and tenders that do not fall under these three categories

Services procurement by the US

- Under full and open competition category, low share of services in total contract value from all sources and high share of services in total contract value from non-US means
- The non-US agencies have been contracted for the largest part of the service contract value



Nature, Size and Trends in Government Procurement by the EU

- Data on public procurement by the EU member countries available on the TED (Tenders Electronic Daily) site
- (URL: <u>http://ted.europa.eu/TED/main/HomePage.do</u>)
- Procurements separately for the two member country markets, Germany and UK were analyzed
- Projection for markets in EU-27 countries taken together is made on the basis of procurements in these two markets



Nature, Size and Trends in Government Procurement by the UK

- The total number of procurement transactions during 2008-2009 that were analyzed for the UK was around 50,000
- There are seven competition categories of tender for government procurement in UK:
 - Accelerated negotiated, Accelerated restricted, Competitive dialogue, Negotiated with a call for competition, Negotiated without a call for competition, open and restricted



Decomposition of Procurement by UK (Competitive Dialogue in 2008)




But most of the procurements in these categories have actually been contracted to the US agencies.

- Part of the reason of almost all procurement by the UK being from the EU sources may lie in the positive externalities (or advantage) that the EU rules of common or internal market offers to all the member countries
- In contrast, the US procurement may not be biased in favour of the NAFTA members even if USA may have linked its procurement preference to intra-NAFTA commodity trade preference




• R&D constitutes 84% of share, Financial and insurance services 13% in 2008

•In 2009, Architectural and Construction services 57%, Business Services (including Law and Marketing) 7% Financial and insurance services at a share_of_13% Access to US and EU markets

- The only service procurement that was contracted outside EU (Australia) was the IT & ITeS
- The major problem with the German data as extracted from the Award Notices is that often the country to which a contracted agency belongs is not mentioned
- In 2008, 1.76 percent of total procurement was contracted to agencies with no reported country of origin
- In 2009, share of procurement from such agencies in total procurement was 1.14 %

Despite larger volume and share of procurement of IT and ITeS by the US government, the share of non-US sources was much larger in the total procurement of medicines and drugs in 2008

14.5% share of procurement from the non-US sources in total procurement of medicines & drugs is more than double of the overall share of 6% for the non-US sources in total procurement of all goods and services

Actual Procurements from Indian Agencies and Estimated Gains for India

- Procurements made from India by the US government agencies increased from \$2.8 mn in 2008 to \$3.1 mn in 2009
- Share of India in total procurement by USA had been 0.0006 percent in 2008 and 0.0007 percent in 2009
- 2008 the highest share was 10% for maintenance, repair and alteration of real estates
- 2009 laboratory testing 12%, maintenance, repair and rebuilding of equipments 8.5% and lease or rental of equipment 7%

- No procurement was made by Germany from India
- UK made two procurements from India amounting to approximately 2-3 million GBP
- For the product code 74 (not defined in CPV code), UK procured 1.1 million worth of services from India
- For another category, again not defined in CPV code, 7.8 million worth of procurement was made from Japan and India

If we make a projection of India's likely share taking into account procurements of 2-3 million GBP in product categories not defined in CPV, likely share will rise to 7-8 million GBP or 10-12 million USD



Concluding Remarks

- Service procurement had been much larger than goods procurement in all markets
- Procurement by the US government from sources outside the United States had actually grown from 6 percent in 2008 to little over 7 percent in 2009
- procurement of goods and services by the UK and German governments from sources outside the EU had been negligible
- By the most liberal estimation, if India had acceded to the GPA agreement it could have a share of US government procurement to the tune of 500-550 million USD
- In the EU markets, on the other hand, the likely gain would have been only to the tune of 10-12 million USD



Concluding Remarks

- But, these moderate gains are to be weighed against the potential costs of acceding to the GPA
- These costs may involve
 - costs of switching over from the existing procurement regime to new systems mandated under international rules
 - restriction on the development policy space available to India through government spending
 - its ability to assist local companies, and particular socio-economic groups or ethnic communities, or underdeveloped regions
