

Kamna Chaudhary is an Associate (Legal) at the Centre for WTO Studies, Indian Institute of Foreign Trade, with over eight years of experience across multilateral trade negotiations, litigation, and legal academia. Kamna completed her B.A. LL.B. (Hons.) from Dr. Ram Manohar Lohiya National Law University, Lucknow, and her LL.M. with a specialisation in Intellectual Property Rights and Business Laws from the National Law Institute University, Bhopal. She is an enrolled advocate with the Bar Council of Uttar Pradesh, has qualified the All India Bar Examination, and holds a UGC-NET qualification in Law. Kamna began her career in litigation, practising for five years with a senior counsel on civil and family law matters, and thereafter moved into legal academia before specialising in international trade law and policy. She has served on Indian delegations to the 14th WTO Ministerial Conference in Yaoundé and India's 8th Trade Policy Review in Geneva, and was part of the negotiating team for the BRICS Agriculture Working Group in Indore.
